- o **October 25 meeting minutes** - no updates, deferred due to lack of quorum
- o Dave K met with Ron Beard, GM and Shawn Pelchat on Monday 4/24 to review upcoming outdoor court project work.

Tennis/multi-use Courts

- **court surface colors** - Dave S & Dave K discussed base color options provided by VT Rec. VT Rec stated they did have premium colors available as well for an additional cost. The driving factor would be to minimize visual contrast to surrounding landscape...use earth colors (ie: green). Dave K will consult with VT Rec on color allowance and surcharge rules.
- Question to VT Rec, is there a cost difference for 2 vs 3 vs 4 colors.
 - **Option 1:** racket area: dark green outside, dark blue inside, white lines; basketball area: key/3 point circle light green, blue lines
 - **Option 2:** racket area: dark green outside & inside, white lines; basketball area: key/3 point circle medium green, blue lines
 - **Option 3:** racket area: dark green outside, medium green inside, white lines; basketball area: key/3 point circle medium green, blue lines

Dave K will mock-up all green option and consult with tennis players on playability of options listed above.
- **court signage** - quick review of list. Decided to use what is allowed vs what's not allowed to avoid confusion. Add sign for 'keep gate closed' Dave K stated Ron Beard had suggested creating a diagram to explain line colors on multi-use courts.
- **questions for VT Rec** - Dave K contacted VT Rec last week to discuss upcoming tasks.
 - asphalt pricing update - Dave K will inquire
- **questions from VT Rec**
 - crushed stone or grass around courts - Ron B and Shawn Pelchat support stone on all sides except for front of lower court abutting the lawn.

Basketball/H-cap Parking

- **hoop install schedule** - Ron stated within two weeks. Ron asked Shawn when the MegaSlam install could be scheduled. We reviewed the installation guide. Dave K agreed to meet onsite to mark the location of the footing.
- **H-cap parking** - Dave K noted the current layout may have to shift to insure truck access when 2 vehicles are parked. Ron was not concerned as frequency would be very limited. He also stated the entry drive could be expanded to widen access.
Brief discussion on a fence between the B-ball court and H-cap parking. Ron and Shawn preferred a removable fence for maintenance reasons. Perhaps sleeved posts.
- **court surface colors** - same as racket courts

- **open area between court and building** (*stone or pavers*) - Feedback from members, simplify of maintenance and usability were considered. Ron and Shawn were in favor of a patio area for a couple picnic tables. Pavers will be used to improve access.
- **walkway installation** (schedule and materials) - no update
- **walkway appearance** (wedding impacts and aesthetics - Ron stated weddings are on hold. no update

Open Topics

- **Horseshoe and Shuffleboard courts** - The shuffleboard and horseshoe pits are in need of refurbishment. Shawn requested that the shuffleboard be differed until after he completes renovations to building exterior. Court paint is available in storage.

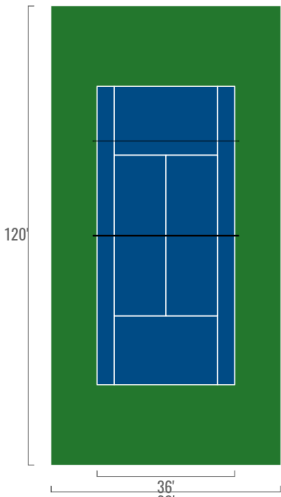
Courts for owners and their guests only

No skateboards, bicycles, scooters, or rollerblades

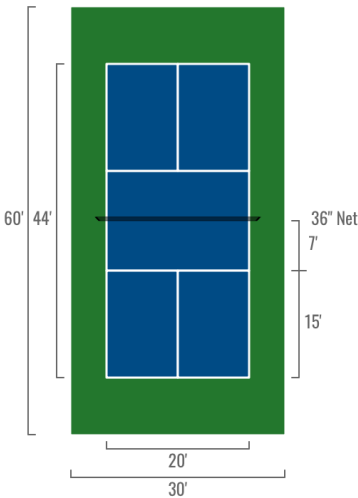

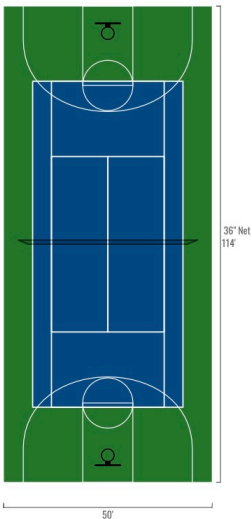
