## Permission & Consent Agreement ("Agreement")

**To be signed by parent/guardian of a minor child between the ages of 14 - 17 years of age who wishes to use the gym on the premises of Waterville Estates Village District.**

Please read this Agreement carefully. It must be signed by an adult (eighteen years and older) parent or legal guardian of the minor identified below who is an "owner" (a person that has a deed to a home or condominium within Waterville Estates).

This Agreement is between the "owner" identified below and the Waterville Estates Village District and pertains to the owner's minor child being permitted to enter, be present at, and/or use a gym, and the gym equipment therein, located on the premises of and owned by the Waterville Estates Village District (the "gym").

In consideration of the owner's minor child being permitted to enter, be present at, and/or use the gym and gym equipment, the undersigned owner agrees to the following:

1. He/she/they is/are eighteen years of age or older. (**Owner's initials here** \_\_\_\_\_)
2. He/she/they is/are an owner of property within the Waterville Estates Village District. (**Owner's initials here** \_\_\_\_\_)
3. He/she/they is/are the parent or legal guardian of the minor identified herein. (**Owner's initials here** \_\_\_\_\_)
4. His/her/their minor child identified herein is between 14 and 17 years of age as of the date of the owner's signature below. (**Owner's initials here** \_\_\_\_\_)
5. He/she/they understand(s) that observing and/or participating in fitness related activity including, but not limited to, the use of gym equipment exposes his/her/their minor child to risks of serious bodily injury, psychiatric injury, personal injury, death, and/or damage to or loss of property. 6. He/she/they grant(s) permission and consents to his/her/their minor child entering, being present in/at the gym and/or using gym equipment at/within the gym. (**Owner's initials here** \_\_\_\_\_)
7. He/she/they or another parent/legal guardian of the minor child must accompany his/her/their minor child at all times while the minor child is present at/in the gym. (**Owner's initials here** \_\_\_\_\_)
8. Even if his/her/their minor child has parental/guardian approval to use the gym, if the minor child is not accompanied by his/her/their parent/legal guardian, his/her/their minor child is prohibited from entering, being present at, and/or using the gym/gym equipment. 9. His/her/their minor child must adhere to all the rules, terms of use, and instructions pertaining to the gym and/or issued by Waterville Estates Village District and its officials, agents, and employees. **(Owner's initials here \_\_\_\_\_)**
10. All gym equipment used must be used in the manor for which it is intended and must be wiped down after being used. **(Owner's initials here \_\_\_\_\_)**
11. If the gym or gym equipment is misused by his/her/their minor child, or if he/she/they or another parent or legal guardian of the minor child leave(s) the minor child unattended at/in the gym, this Agreement is/becomes null and void. **(Owner's initials here \_\_\_\_\_)**

His/her/their or his/her/their minor child's failure to comply with the rules, terms of use, and instructions of Waterville Estates Village District and/or its officials, agents, and employees will result in suspension of owner passes for a time period ranging from 30 days to 1 year depending on the severity of the noncompliance and/or history of prior incidents of non-compliance, in the sole discretion of the Waterville Estates Village District and its officials, agents, and employees. **(Owner's initials here \_\_\_\_\_)**
13. I understand and voluntarily accept full responsibility for the risk of injury or loss arising out of or related to my or my minor child's use of the Waterville Estates Village District's facilities. **(Owner's initials here \_\_\_\_\_)**


